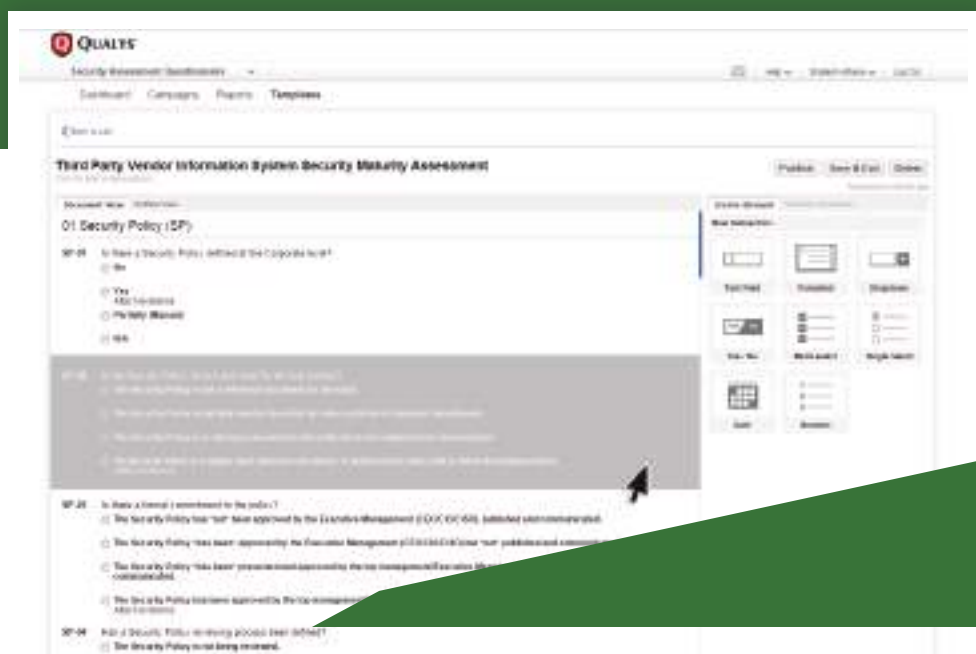

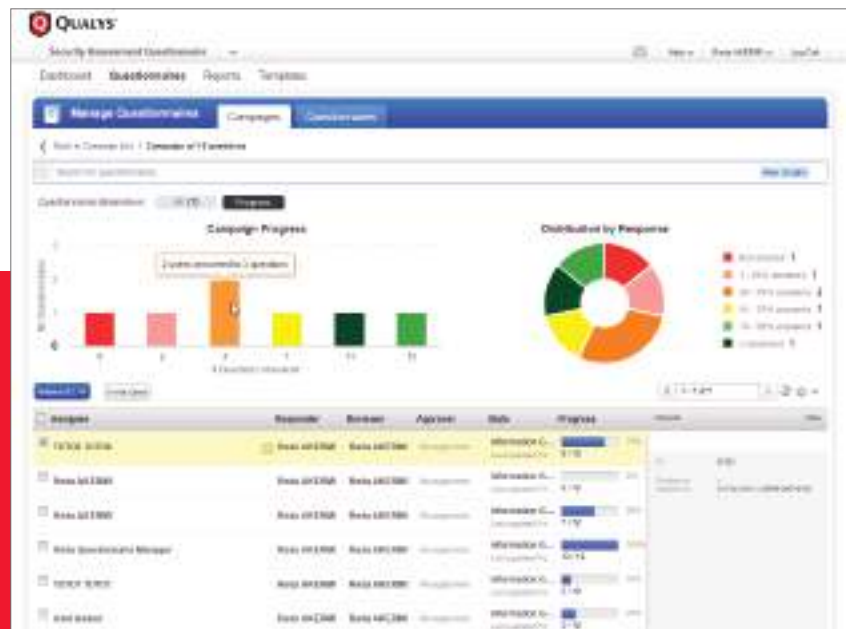
Instant access from any web browser with role-based capabilities
